World's Oldest Rock Art

• Australian Scientists have recently found the world's oldest figurative art in a cave in Indonesia.

Stages of Economic Integration

- **Preferential Trade Agreement** It is a trading bloc that gives preferential access to certain products from the participating countries by reducing tariffs but not abolishing them completely.
- Free Trade Agreement It is a trade bloc, which eliminates tariffs, import quotas, and preferences on most (if not all) goods and services traded between participating countries.
- **Customs Union** It is an agreement to have free trade among countries and to adopt common external barriers against any other country interested in exporting to these countries.
- **Common Market** A type of custom union where there are common policies on product regulation, and free movement of goods and services, capital and labour.

• **Economic Union** – It is a trade bloc with common policies on product regulation, freedom of movement of goods, services and the factors of production (capital and labour) and a common external trade policy.

- Indira Gandhi Prize for Peace, Disarmament and Development is the prestigious award accorded annually by Indira Gandhi Memorial Trust.
- Individuals or organisations in recognition of efforts towards promoting international peace, development and a new international economic order, scientific discoveries used for the larger good of humanity and enlarging the scope of freedom will be awarded.

- \bullet CSE is an Environmental NGO and a public interest research and advocacy organisation based in New Delhi. $\mbox{\sc New Delhi}.$
- It was awarded for its pioneering work in the field of environmental education and protection and also for keeping the issue of environmental sustainability at the forefront of national attention and public policy. \n

Indian Wind Turbine Certification Scheme

- It incorporated various guidelines from turbine certification scheme.
- It will not only present a framework for standards, but also gratify to the technical regulations and requirements issued by Central Electricity Authority (CEA), guidelines issued by MNRE and other international guidelines.
- Type Certification of wind turbines plays an active role in ensuring that wind turbines in India meet the requirements of requisite international standards.
