- The Commission for Air Quality Management (CAQM) has recently said that measures under 'Stage-1' of the Graded Response Action Plan (GRAP) will be enforced in the NCR with immediate effect.
- It is an emergency measures to prevent deterioration of air quality in Delhi and other parts of the NCR.
- The GRAP was first notified in January 2017 by the Ministry of Environment, Forest and Climate Change.
- This was based on a plan that was submitted by the Central Pollution Control Board (CPCB) in November 2016.
- According to the GRAP notification, the task of implementing the GRAP fell on the now dissolved Environment Pollution (Prevention and Control) Authority for the NCR.
- From 2021 onwards, the GRAP is being implemented by the CAQM.
- The GRAP has four stages :
- Stage 1 AQI Poor (201 to 300)
- $\circ~$ Stage 2 AQI Very poor (301 to 400)
- Stage 3 AQI Severe (401 to 450)
- Stage 4 AQI Severe + (more than 450)
- 2) Consider the following statements with respect to Inter-State River Water Dispute Act, 1956

Inter-State River Water Dispute Act, 1956

- The inter-State river disputes in India are governed by the Inter-State River Water Dispute Act, 1956.
- State may request the Centre to refer an inter-State river dispute to a tribunal for adjudication.
- If disputes cannot be settled, the centre can setup a Water Disputes Tribunal to resolve within one year.
- The tribunal must decide on the dispute within three years, which may be extended by two years.
- All decisions of the Tribunal are final and binding.
- After its publication in the Official Gazette, a decision has the same force as an order of the Supreme Court.
- 3) Consider the following statements with respect to Rajarajeswaram Temple:
 - 1. It was built by Raja Raja I and was also called as Brihadeeswara Temple.
 - 2. The temple was built in dravidian architecture and the complete structure of the temple is made out of granite.

The Brihadeeswara Temple

- The Brihadeeswara Temple also known as Peruvudaiyar Kovil is located in Thanjavur.
- The temple was dedicated to Lord Shiva.
- The temple was built around 1010 AD by the Chola king Rajaraja Chola I.
- The temple was originally called as Rajarajeswaram.
- It is one among the three 'Great Living Chola Temples'.
- The site includes three great 11th- and 12th-century temples
- 1. The Brihadisvara temple,
- 2. The Gangaikondacholisvaram and
- 3. The Airavatesvara temple
- The complex is also listed as a part of the UNESCO World Heritage Sites.

- The structure is an example of Dravidian architecture and represents the ideology of Chola Empire.
- The vimana symbolises the holy Meru, Mount Kailash, the sacred abode of Shiva.

Post Devolution Revenue Deficit (PDRD) Grant

- The Union Finance Ministry has recently released the monthly instalments of Post Devolution Revenue Deficit (PDRD) Grant for states.
- The grant has been released as per the recommendations of the Fifteenth Finance Commission.
- PDRD grants are released to the States as per the recommendations of the successive Finance Commissions.
- Its main objective is to meet the gap in Revenue Accounts of the States post devolution.
- The funds will be released by the Department of Expenditure, Ministry of Finance.
- The PDRD grant are provided to the States under Article 275 of the Constitution.

• The grant is released to the recommended States in 12 equated monthly instalments.
