### Poshan Bhi Padhai Bhi (PBPB)

- Poshan Bhi Padhai Bhi (PBPB) is an **Early Childhood Care and Education Program (ECCE)** to help India develop the high-quality pre-school network at Anganwadi Centers (AWCs).
- Under the programme, steps have been taken to bolster early childhood care and education and good nutrition practices through development.
- PBPB is not a separate scheme but is a programme component under ECCE of Anganwadi services **under Mission Poshan 2.0**.
- The implementation of PBPB includes conducting Capacity Building trainings for Integrated Child Development Services (ICDS) functionaries.
- The objectives of the training program include:
  - Promoting early stimulation for the first 1000 days and ECCE for children 3-6 years of age.
  - Developing early childhood care and education understanding of Anganwadi Workers.
  - Emphasizing developmental domains such as socio-emotional-ethical, physical and motor, cognitive, etc., and the development of Foundational Literacy and Numeracy (FLN).
  - Reinforcing nutrition knowledge of Anganwadi Workers.

## DISHA Scheme

- DISHA - **Designing Innovative Solutions for Holistic Access** to Justice.
- It scheme aims to design and consolidate various initiatives to provide **citizen- centric delivery of legal services** enunciated under **Articles 39A, 14 and 21** of the Constitution of India.
- The scheme is launched for a period of five years 2021-2026 to advance the cause of access to justice.
- The scheme was introduced by **Department of Justice**.
- It aids to create awareness and dissemination through use of technology and developing simplified Information, Education and Communication (IEC) material for the masses.
- The 3 subcomponents under the scheme includes:
  - **Tele-Law: Reaching the Unreached** - An e-interface platform that aims to empower people through pre-litigation advice for rightfully claiming their entitlements and for timely redressal of their difficulties.
  - **Nyaya Bandhu (Pro Bono Legal Services)** - Aims to provide **free legal assistance** and counsel to the marginalized sections.
  - **Legal Literacy and Legal Awareness** - Aims to enable the vulnerable sections of society to have access to information about their legal rights, entitlements.
    - It also creates better legal awareness so as to make justice delivery system citizen-centric.

## 100 Microsites Project

- The National Health Authority (NHA) has introduced the 100 Microsites Project under the **Ayushman Bharat Digital Mission (ABDM)**.
- The primary goal of the Microsites is to *create small ecosystems within specific geographic areas* where complete ABDM adoption is achieved, ensuring the digitization of the entire patient journey.
- **Intended objectives of the project**
  - Targeted adoption efforts in private sector
  - Showcase end-to-end ABDM adoption
  - On-Ground response and feedback
- **A Microsite** is a focused region comprising of all small-medium sized healthcare facilities such as clinics, hospitals, labs, pharmacies within that area, which may be on-boarded onto the ABDM ecosystem.

- **Category A Microsite:** Consists of at least 1000 Healthcare facilities
- **Category B Microsite:** Consists of 500 to 1000 Healthcare facilities
- One State/UT can implement multiple Microsites.
- The project will be implemented by **State Mission Directors of Ayushman Bharat Digital Mission.**
- The financial resources and overall guidance would be provided by National Health Authority.
- Primary responsibility to run a Microsite is **with the States/UTs.**

## Finance Commission

- **Article 280** provides for a Finance Commission as a quasi-judicial body.
- The Finance Commission consists of a chairman and four other members to be appointed by the president.
- They hold office for such period as specified by the president in his order and they are eligible for reappointment.
- The Constitution authorises the Parliament to determine the qualifications of members of the commission and the manner in which they should be selected.
- It is required to make recommendations to the President on the following matters:
  - The distribution of the net proceeds of taxes to be shared between the Centre and the states and the allocation between the states, the respective shares of such proceeds.
  - The principles which should govern the grants-in-aid to the states by the Centre.

- Any other matter referred to it by the President in the interests of sound finance.

## 15th Finance Commission

- The 15th Finance Commission was constituted on 27 November 2017.
- Shri N.K. Singh is the chairman of 15th Finance Commission.
- Criteria set by 15th Finance Commission includes:
  - **Income distance** - A state with lower per capita income will have a higher share to maintain equity among states.
  - **Demographic performance** - States with a lower fertility ratio will be scored higher on this criterion.
  - **Forest and ecology** - It was arrived by calculating the share of the dense forest of each state in the total dense forest of all the states.
  - **Tax and fiscal efforts** - It is measured as the ratio of the average per capita own tax revenue and the average per capita state GDP during the three years between 2016-17 and 2018-19.
