Recently the Union Cabinet approved establishment of an autonomous body Mera Yuva Bharat (MY Bharat) to focus on Youth led development.

- It is an autonomous body to serve as an overarching enabling mechanism powered by technology for youth development youth led development.
- It provides equitable access to youth to actualize their aspirations and build Viksit (advanced) Bharat across the entire spectrum of the Government.
- The primary objective of Mera Yuva Bharat (MY Bharat) is to make it a whole of Government platform for youth development.
- It will benefit the youth in the age group of 15-29 years, which is in line with the definition of 'Youth' in the National Youth Policy.
- The country has around 40 crore people in the age group of 15-29 years.
- In case of programme components specifically meant for the *adolescents, the beneficiaries will be in the age group of 10-19 years.*
- It will centralize youth database and offer suitable opportunities to engage in voluntary work across the country.
- It will act as a one-stop shop for young people and various central government ministries.
- Under this platform there will be no financial remuneration.
- Mera Yuva Bharat (MY Bharat) would lead to:
  - Leadership Development in the Youth,
  - Better alignment between youth aspirations and community needs,
  - Enhanced efficiency through Convergence of existing programmes,
  - $\circ~$  Improved two-way communication to connect youth government initiatives and activities of other stakeholder that engage with youth and
  - Ensuring accessibility by creating a physical ecosystem.

#### **Intelligent Grievance Monitoring System (IGMS) 2.0**

Ministry of Personnel Public Grievances and Pensions recently launched Intelligent Grievance Monitoring System (IGMS) 2.0 Public Grievance portal and Automated Analysis in Tree Dashboard.

- The IGMS 2.0 is a major upgradation of Centralised Public Grievance Redress and Monitoring System (CPGRAMS) portal with artificial intelligence (AI) and machine learning (ML) capabilities.
- IGMS2.0 Dashboard has been implemented by IIT Kanpur.
- The Dashboard provides instant tabular analysis of Grievances Filed & Disposed, State-wise & District-wise Grievances Filed & Ministry-wise data.
- The Dashboard will also help the officials identify the root cause of the grievance.
- **CPGRAMS** is an online platform available to the citizens 24x7 to lodge their grievances to the public authorities on any subject related to service delivery.
- It is a single portal connected to all the Ministries/Departments of Government of India and States.
- Every Ministry and States have role-based access to this system.
- CPGRAMS is also accessible to the citizens through standalone mobile application downloadable through Google Play store and mobile application integrated with UMANG.
- Unified Mobile Application for New-age Governance (UMANG) is a one stop gateway to all government schemes and services through different channels like Mobile Application(iOS, Android), Chatbot, Voice Bot and Website.
- UMANG is an initiative of National e-Governance Division (NeGD), Ministry of Electronics and Information Technology (MeitY).

# Niobium

Recently the Cabinet approved royalty rates for mining of 3 critical and strategic minerals such as Lithium, Niobium and Rare Earth Elements (REEs).

- Niobium also known as columbium, is a chemical element with the symbol Nb (formerly Cb) and atomic number 41.
- Niobium is a light grey, crystalline and ductile transition **metal**.
- Pure niobium has a hardness similar to that of pure titanium, and it has similar ductility to iron.
- Niobium is used in alloys, tools and dies and superconductive magnets.
- Niobium in one of the <u>Critical Minerals</u> in India.
- It is not one of the <u>17 rare earth elements (REE)</u>.
- The main source of Niobium element is the mineral columbite.
- This mineral also contains tantalum and the two elements are mined together.
- Columbite is found in Canada, Brazil, Australia, Nigeria and elsewhere.
- Some niobium is also produced as a by-product of tin extraction.
- The Mines and Minerals (Development and Regulation) Amendment act, 2023 delisted 6 minerals, including Lithium and Niobium, from the list of atomic minerals.

## 'Ayyampalayam Nettai' coconut variety

# Recently the farmers in the region of Ayyampalayam, Dindigul district of **Tamil Nadu** have sent their application for getting a GI tag for Ayyampalayam Nettai' coconut variety.

- 'Ayyampalayam Nettai' coconut variety is grown in coconut farms just above the dam, bordering the catchment area in Ayyampalayam, Dindigul district of Tamil Nadu.
- These century-old trees that have *more than 60% oil content* and an extremely sweet kernel have still not lost their crop yielding ability.
- It has oval shaped nuts that are *drought resistant and disease resistant*.
- Though some trees were attacked by whiteflies and leaf spot disease, these trees were able to withstand it unlike the hybrid trees.
- On an average, a single tree can give a yield of about 120 nuts per year and if fertilizers are applied the yield can increase to about 150 nuts.
- The hybrid trees, on the other hand, start yielding early giving about 200 nuts per tree per year.
- This variety also promotes sustainable intercropping.
- 'Ayyampalayam Nettai' coconut variety is yet to receive GI tag.

#### **Operation Ajay**

Recently the ministry of external affairs announced an initiative Operation 'Ajay' to evacuate Indian nationals from Israel.

- Operation Ajay is a major operation to evacuate its citizens who wish to return from conflict-hit Israel.
- There are at least 900 Indian students who are enrolled in various Israeli universities and institutions.
- This will be the second evacuation operation in 2023, after <u>Operation Kaveri</u> that brought back several thousand Indian citizens from conflict-torn **Sudan**.
- **Operation Ganga** Is an operation executed by the Indian government to rescue Indians in the war hit *Ukraine*.
- **Operation Devi Shakti** Evacuation of Indians and Afghans and shipment of humanitarian assistance for the people of *Afghanistan*.
