### 6X6X6 strategy

- It is implemented under Anemia Mukt Bharat (AMB) which aims to reduce anemia among 6 beneficiaries age groups through implementation of 6 interventions and 6 institutional mechanisms.
- 6 beneficiaries age groups:
  - Children between 6 and 59 months
  - Children between 5 and 9 years
  - Adolescents between 10 19 years
  - Women of reproductive age (15-49 years)
  - Pregnant women & Lactating women

### • 6 interventions:

- Prophylactic Iron Folic Acid Supplementation
- Periodic de-worming
- Intensified year-round behavior change communication campaign
- Testing of anemia using digital invasive hemoglobinometer and point of care treatment
- Mandatory provision of Iron Folic Acid fortified foods in public health programs
- Addressing non-nutritional causes of anemia in endemic pockets

### • 6 institutional mechanisms:

- Inter-ministerial coordination
- $\circ\,$  Convergence with other ministries
- Strengthening supply chain and logistics
- Engaging National Center of Excellence
- Advanced research on anemia control for capacity building of health care provider
- Monitoring using AMB dashboard

# International Treaty on Plant Genetic Resources for Food and Agriculture

- International Treaty on Plant Genetic Resources for Food and Agriculture, also called as *Plant Treaty*.
- **Objective** Conservation and sustainable use of all plant genetic resources for food and agriculture and the fair and equitable sharing of the benefits arising out of their use.
- It is in harmony with the Convention on Biological Diversity, for sustainable agriculture and food security.
- It is *signed by many countries including India*.

## Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006.

- It is also known as Forest Rights Act (FRA), 2006.
- The Act aims to <u>legally recognize and protect the rights of tribal</u> <u>communities</u> and other traditional forest dwellers over the forest land and resources they have traditionally used.
- Key Provisions
  - Individual Forest Rights (IFR) Land titles for cultivation/habitation.

- Community Forest Rights (CFR) Rights over forest resources and management.
- Gram Sabha's Role Primary authority to initiate and verify claims.

## Frankincense

- It is a fragrant resin obtained from various species of trees belonging to the Boswellia genus.
- **Significance** Historically famous as <u>one of the three gifts</u> (along with gold and myrrh) brought to the infant Jesus.
- Used for centuries in *perfumes and incense*.

• Research suggests <u>potential medicinal benefits</u> due to its <u>anti-inflammatory properties</u> (for conditions like ulcerative colitis, IBS, bronchitis, sinusitis) and possible use in reducing asthma risk.
