- 1) Consider the following statements regarding the new Overseas Citizen Of India (OCI) Portal:
  - 1. It is accessible at the same URL as the existing OCI Services portal.
  - 2. It processes approximately 2,000 applications per day.
  - 3. It provides enhanced functionality and advanced security features.

Which of the statements given above is/are correct?

- Statement 3 is correct. The new portal "will provide enhanced functionality, advanced security, and a user-friendly experience."

**Answer:** (c) 1 and 3 only

- 2) With reference to OpenAI's local data residency implementation in India, consider the following statements:
  - 1. It allows 'data at rest' such as prompts and uploaded files to be stored within India.
  - 2. It has fully addressed concerns about data in transit during model inference.
  - 3. The Reserve Bank of India (RBI) does not permit any form of cross-border processing of payment data.

Which of the statements given above is/are correct?

- a. 1 only
- b. 1 and 2 only
- c. 2 and 3 only
- d. 1, 2 and 3

## **Explanation:**
