- Vermicompost is the product of the composting process using various species of worms, usually red wigglers, white worms, and other earthworms.
- It increases the water holding capacity in the soil due to increased burrowing of soil by worms
- 2. Consider the following statements about Commission for Agricultural Costs and Prices
 - 1. It is a statutory body mandated to recommend minimum support prices (MSPs) to incentivize the cultivators to adopt modern technology, and raise productivity and overall grain production in line with the emerging demand patterns in the country
 - 2. Kharif crops, Rabi crops, Sugarcane, Raw Jute and Copra are the only commodities for which CACP recommends MSPs.
