For addressing Mitigation, Globally and Nationally also we have took alot of steps like IPCC COP26, 27, 28 ; Panchamrit, National Determined Goals etc. But Adaptation measures are not in line with mitigation intems of Goals, targets, finances.

Challenges in GIGA ↓

- ① Implementing GIGA is bit complex because of the difference in National policy, Administrative constraints, economic development.
- ② There is no universal metric to measure the Adaptative measures. Hence comparing and reviewing became difficult.
