- Bharat Electronics Limited (BEL) has signed a contract with Indian Navy for initially supply 20 Light Amplification by Stimulated Emission of Radiation Dazzlers (Laser Dazzlers) in New Delhi recently.
- The Laser Dazzler would be manufactured by BEL, Pune plant.

## Laser Dazzler

- It is used as a non-lethal method for warning and stopping suspicious vehicles/boats/aircrafts/UAVs/pirates etc. from approaching secured areas during both day and night.



- It is capable of dazzle and thereby suppress the person's/optical sensor's action with disability glare in case of non-compliance to orders.
- It disorient/ confuse/blind a person temporarily.
- It also dazzles and distract aircraft/UAVs.
- It is a portable, shoulder operated and ruggedized for military use in adverse environmental conditions.
- Laser dazzler technology was developed by Defence Research and Development Organisation (DRDO).

### **Atmanirbhar Bharat**

- This unique product is indigenously designed and developed for first time **for the Armed Forces**.
- It will support the 'Atmanirbhar Bharat' initiative of Prime Minister Shri Narendra Modi.

### **National Family Health Survey (NFHS)**

- It is a large-scale nationwide survey of representative households.
- The MoHFW has designated International Institute for Population Sciences in Mumbai as the nodal agency.
- The survey is funded by the United States Agency for International Development (USAID) with supplementary support from UNICEF.
- The survey is based on 131 parameters.

### **ASHA-India**

- It aims to promote domestic research and entrepreneurship by providing incubation and acceleration support to potential future technologies.
- Under ASHA-India initiative, five ASHA-India Centers have been set up for providing incubation and acceleration support.
- The potential technology winners under acceleration support will be announced by the Prime Minister.

- The technologies, processes and materials identified through this initiative will provide a major fillip to young creative minds, start-ups, innovators and entrepreneurs.

### **R P Tiwari Committee**

- The University Grants Commission (UGC) has set up a seven-member committee headed by R P Tiwari.
- This committee will consider the issue of holding common entrance test at undergraduate (UG) level only from the next academic year in central universities to provide a single platform for admission.
- The new National Education Policy (NEP) advocates reducing the number of entrance tests to eliminate the need for taking coaching for these exams.
- If the NEP suggestion is implemented, the National Testing Agency will be established.
- This Agency will be tasked to conduct a common aptitude test as well as specialised common exams for different disciplines at least twice a year, for admission to bachelor degrees in central universities.

### **Lithium Refinery**

- India's first Lithium refinery will be set up in Gujarat.
- It will process Lithium ore to produce battery-grade material.
- Lithium is a rare element not usually found in India, which would be imported from Australia and processed in this refinery.
- The proposed Lithium refinery will help make Gujarat a domestic hub for Li-ion batteries manufacturing.
- TDS Lithium-Ion Battery Gujarat Private Ltd is India's first Lithium-ion battery manufacturing plant in Gujarat.
- This Lithium ion battery manufacturing plant is expected to become operational by January or February 2021.

### **International Organization of Securities Commissions (IOSCO)**

- The IOSCO is the international organization that brings together the world's securities regulators, covering more than 95% of the world's securities markets.
- It is the global standard setter for the securities sector, which is HQ in Madrid, Spain.
- IOSCO works closely with the G20 and the Financial Stability Board (FSB) in setting up the standards for strengthening the securities markets.
- Recently International Financial Services Centres Authority (IFSCA) has become an Associate Member of the International Organization of Securities Commissions (IOSCO)

### **Eco-Sensitive Zones**

- Its objective is to minimise the negative impacts of certain activities on the fragile ecosystem encompassing the protected areas.
  - In case of places with sensitive corridors, connectivity and ecologically important patches, crucial for landscape linkage, even area beyond 10 km width can also be included in the eco-sensitive zone.
  - Activities Allowed under ESZs are
1. **Prohibited activities** - Examples are Commercial mining, saw mills, industries causing pollution (air, water, soil, noise etc), and establishment of major hydroelectric projects (HEP).
  2. **Regulated activities** - Examples are Felling of trees, establishment of hotels and resorts, commercial use of natural water, erection of electrical cables, etc.
  3. **Permitted activities** - Examples are ongoing agricultural or horticultural practices, use of renewable energy sources, and adoption of green technology for all activities.

### **Global Housing Technology Challenge (GHTC)**

- Launched in 2019, the challenge is undertaken under the Pradhan Mantri Awas Yojana Urban (PMAY-U).

- GHTC focuses on identifying and mainstreaming proven demonstrable technologies for lighthouse projects and spotting potential future technologies for incubation and acceleration support through ASHA (Affordable Sustainable Housing Accelerators) – India.
- Light House Projects (LHPs) under GHTC-India comprise about 1000 houses at each location along with allied infrastructure facilities.
- These LHPs demonstrate a variety of technologies, including Prefabricated Sandwich Panel System in LHP at Indore, Monolithic Concrete Construction using Tunnel Formwork etc.

### **Appointment of Judges of High Courts**

- The procedure of appointing the Judges of the High Courts in India is slightly different from the appointment of the Judges of the Supreme Court.
- A person who have selected to become a high court judge should have held a judicial office in the territory of India for ten years or should have been an advocate of high court(s) for ten years.
- There is no minimum age fixed for high Court judges, and unlike in Supreme Court, there is no provision for appointment of a distinguished jurist as a judge of a high court.
- As per article 217, the chief Justice of the high court is appointed by the President in consultation with the Chief justice of India as well as the Governor of the state in question.

### **Lightning Strike**

- Moving free electrons in the clouds cause more collisions and more electrons, a chain reaction ensues.
- This process results in a situation in which the top layer of the cloud gets positively charged, while the middle layer is negatively charged.
- The electrical potential difference between the two layers is huge of the order of a billion to 10 billion volts.





- An enormous amount of heat is produced, and this leads to the heating of the air column between the two layers of the cloud.
- This heat gives the air column a reddish appearance during lightning.
- As the heated air column expands, it produces shock waves that result in thunder.
- Lightning incidents in India report is published by Climate Resilient Observing Systems Promotion Council (CROPC), a non-profit organisation that works closely IMD to disseminate early lightning forecasts.

### Digital Payment Index (DPI)

- It is released by RBI with March 2018 as the base period.
- The RBI-DPI comprises five broad parameters that enable the measurement of deepening and expansion of digital payments in the country over different time periods.
- The parameters are including
  1. Payment Enablers (weight 25%),
  2. Payment Infrastructure -Demand-side factors and (10%),
  3. Payment Infrastructure – Supply-side factors (15%),
  4. Payment Performance (45%)
  5. Consumer Centricity (5%).
- The RBI-DPI shall be published on RBI's website on a semi-annual basis from March 2021 onwards with a lag of 4 months.

### National Police K-9 Journal

- Recently, the Union Home Minister has released the inaugural issue of the "National Police K-9 Journal".
- It is a unique initiative that will further enrich the subjects related to Police Service Dog (K-9) (PSK) teams in the country.
- It is a biannual journal which will be released in April and October every year.
- A special 'Police K9 Cell' was established in November 2019 under the Police

Modernization Division of the Ministry of Home Affairs with the mandate of 'Mainstreaming and Augmentation of Police Service K9s in the country'.

### Geo Engineering

- Climate engineering aka geoengineering is the deliberate and large-scale intervention in the Earth's climate system, usually with the aim of mitigating the adverse effects of global warming.
- Following are the few Geo-Engineering techniques
  1. **Solar Radiation Management (SRM)** - It refers to offsetting the warming effect of greenhouse gases by reflecting more solar radiation (sunlight) back into space.
  2. **Carbon Dioxide Removal (CDR)** - It refers to removing carbon dioxide gas (CO<sub>2</sub>) from the atmosphere and sequestering it for long periods of time.
- LOHAFEX - is an ocean iron fertilization experiment to see if iron can cause algal bloom and trap carbon dioxide from the atmosphere.
- It is jointly planned by the Council of Scientific and Industrial Research (CSIR) in India and the Helmholtz Foundation in Germany.

### Non-Nuclear Aggression Agreement

- It promotes practice of exchanging the list of nuclear installations was carried out under a bilateral arrangement that prohibits them from attacking each other's atomic facilities
- The exchange was made in accordance with Article-II of the Agreement on Prohibition of Attacks against Nuclear Installations and Facilities between Pakistan and India.
- According to Foreign Office (FO), the exercise is carried out consecutively since January 1, 1992.
- The term "nuclear installation or facility" includes nuclear power and research reactors, fuel fabrication, uranium enrichment, isotopes separation and reprocessing facilities.
- It covers any other installations with fresh or irradiated nuclear fuel and materials in any





form and establishments storing significant quantities of radio-active materials.

### **Sukanya Samriddhi Yojana**

- It enables guardians to open a savings account for their girl child with an authorised commercial bank or India Post branch.
- The SSY account can be opened by legal guardians of the girl child provided the girl shouldn't be more than 10 years of age.
- The individuals can open an account with as low as Rs. 250 and they also have to invest a minimum of Rs. 250 to keep the account active.
- The maximum amount that an individual can deposit per year in a Sukanya Samriddhi Yojana account is Rs. 1.5 Lakh.
- The maturity period of an SSY account is 21 years.
- An account holder (the girl) will be able to withdraw from her account once she reaches 18 years of age.

## Answers



1. b

- Ministry of Ports, Shipping and Waterways recently initiated the process of commencing operations of the Seaplane services, on the select routes, under a Special Purpose Vehicle (SPV) framework through prospective airline operators.

### **Sagarmala Seaplane Services (SSPS)**

- The project execution and implementation would be through **Sagarmala Development Company Ltd (SDCL)**, which is under the administrative control of the **Ministry of Ports, Shipping and Waterways**.
- The proposed Origin-Destination pairs under Hub and Spoke model include various islands of Andaman & Nicobar and Lakshadweep, Guwahati Riverfront & Umranso Reservoir in Assam, Yamuna Riverfront / Delhi (as Hub) to Ayodhya, Tehri, Srinagar (Uttarakhand), Chandigarh and many other tourist places of Punjab & HP; Mumbai (as Hub) to Shirdi, Lonavala, Ganpatipule; Surat (as Hub) to Dwarka, Mandvi & Kandla; Khindsi Dam, Nagpur & Erai Dam, Chandrapur (in Maharashtra) and/or any other Hub & Spoke suggested by the Operator.
- One such Seaplane Service is already in operation between Kevadia and Sabarmati Riverfront in Ahmedabad.

### **Sea Plane Services**

- It will utilize the nearby water bodies for take-off and landing and thus connect those places in a much economical way as conventional airport infrastructure like a runway and terminal buildings are not required for seaplane operations.

- India has recently launched the 40th scientific expedition to Antarctica.
- The chartered ice-class vessel MV Vasiliy Golovnin will make this journey and will reach Antarctica in 30 days.

### **Indian Antarctic programme**

- The Indian Antarctic expeditions began in 1981.

- The first trip comprised of a team of 21 scientists and support staff led by Dr SZ Qasim.
- After a humble beginning, the Indian Antarctic programme has credited to have built **three permanent research base stations in Antarctica**—named:

1. Maitri

2. Bharati

3. Dakshin Gangotri

- Dakshin Gangotri** was **decommissioned** on 25 February 1990 and subsequently turned into a supply base.

- As of today, India has two operational research stations in Antarctica named Maitri and Bharati.

- The National Centre for Polar and Ocean Research (NCPOR), Goa, manages the entire Indian Antarctic program.

3. c

- Ministry of Defence (MoD) has recently signed a contract with Bharat Electronics Limited (BEL) for procurement of 10 Lynx U2 Fire Control systems for frontline warships of Indian Navy.

- The Lynx system has been designed and developed indigenously that would further the 'Atmanirbhar Bharat' mission.

### **LYNX U2 GFCS**

- It is a Naval Gun Fire Control System designed to acquire, track and engage targets amidst sea clutter which are disturbing radar-echoes of sea wave crests.
- It is capable of accurately tracking air/surface targets, generating required target data for predicting weapon aiming points and engaging target.
- The target engagement is carried out with the medium/short range gun mounts like Russian AK176, A190 and AK630 and the SRGM available onboard ships.

- Samples of dead migratory water birds found at the Pong Dam Lake in Himachal Pradesh

*have tested positive for avian influenza or bird flu.*

- It has now become the fifth state to report suspected cases of bird flu after Haryana, Rajasthan, Kerala and Madhya Pradesh.

#### **Avian Influenza**

- It is a highly infectious and severe respiratory disease in birds caused by the H5N1 influenza virus.
- It can occasionally infect humans as well, although human-to-human transmission is unusual, according to the World Health Organisation.

#### **The Korea Superconducting Tokamak Advanced Research (KSTAR)**

- It is South Korea's magnetic fusion device.
- The KSTAR has often been referred to as South Korea's "artificial sun".
- It has recently set a new world record for fusion by reaching an ion temperature of over 100 million degrees Celsius for 20 seconds.
- The magnitude of the experiment can be understood from the fact that the Sun burns at 15 million degrees Celsius.
- By comparison, the KSTAR was able to achieve a temperature of over 6.6 times more than that of Sun's.

#### **Kolar Leaf-Nosed Bat**

- It is found in only one cave in Hanumanahalli village in the Kolar district of Karnataka, and its population is less than 200 individuals.
- Its natural habitats are subtropical or tropical dry forests and caves.
- It is currently evaluated as critically endangered by the IUCN.
- Recently Karnataka Forest Department, along with the Bat Conservation India Trust (BCIT), is on a war footing to save the Kolar Leaf-Nosed Bat from extinction.

#### **Aurangabad**

- Aurangzeb, who lived in Aurangabad until his death, tortured and killed Chhatrapati Sambahji, son of the Maratha warrior king Chhatrapati Shivaji.
- Following the historic incident there is a long standing demand for renaming Aurangabad city Sambahji Nagar, which has resurfaced recently.
- The district of Aurangabad is well known for UNESCO Heritage sites such as Ajanta Caves, Aurangabad Caves and Ellora Caves.

#### **National Metrology Conclave**

- National Metrology Conclave 2021 is being organised by CSIR - National Physical Laboratory, which is entering into its 75th year of inception.
- The theme of the conclave is Metrology for the Inclusive Growth of the Nation.
- During the conclave following initiatives are being inaugurated
  1. **National Atomic Timescale** - The National Atomic Timescale generates Indian Standard Time with an accuracy of 2.8 nanosecond.
  2. **Bhartiya Nirdeshak Dravya** - It is supporting testing and calibration of laboratories for quality assurance, at par with international standards.
  3. **National Environmental Standards Laboratory** - will aid self-reliance in the certification of ambient air and industrial emission monitoring equipment.

#### **Natural Gas**

- The National Capital Region of Delhi experienced 4 small earthquakes during April – August 2020, with the first event of magnitude 3.5 on 12 April 2020 in the northeastern boundary of NCT Delhi, during the prevailing lockdown time.
- These earthquakes were followed by a dozen of micro-events including, a few aftershocks.



### Earthquakes

- These are the manifestations of sudden release of strain energy accumulated in the rocks over extensive periods of time in the upper part of the Earth.
- Earthquakes are classified as, Slight ( $M < 5.0$ ), Moderate ( $5.07.0$ ) depending upon the magnitude on Richter's scale.
- An earthquake having a magnitude,  $M < 2.0$  is termed as Micro Earthquake.

### Foreshock

- A relatively small tremor (or an earthquake) that commonly precedes a relatively large magnitude earthquake (called the "main shock"), by seconds to weeks or months and originates in or near the rupture zone of the main shock.

### Aftershock

- An earthquake that follows a large magnitude earthquake called, "main shock" and originates in or around the rupture zone of the main shock. Generally, major earthquakes are followed by a number of aftershocks, which show a decreasing trend in magnitude and frequency with time.

### Isoseismal

- A line connecting points on the Earth's surface, along which the intensity due to an earthquake is the same. It is usually a closed curve around the epicenter.

- *The National Capital Region of Delhi experienced 4 small earthquakes during April – August 2020, with the first event of magnitude 3.5 on 12 April 2020 in the northeastern boundary of NCT Delhi, during the prevailing lockdown time.*
- All these events were located by the National Seismological Network (NSN), being operated and maintained by National Seismological Centre (NCS).

### National Center for Seismology (NCS)

- It is the nodal agency of the Government of India for monitoring of earthquake activity in the country.

- It works under the **Ministry of Earth Sciences**, Government of India.
- NCS maintains National Seismological Network of 115 stations each having state of art equipment and spreading all across the country.
- NCS also monitors earthquake swarm and aftershock through deploying temporary observatory close to the affected region.
- Apart from earthquake monitoring, NCS is also actively involved in the Seismic Hazard Microzonation and seismological research.

3. a

- *The Central Pollution Control Board (CPCB) has constituted a study group to suggest solutions for increase in ammoniacal nitrogen in the Yamuna.*
- The study group will comprise of Delhi Jal Board (DJB), Haryana State Pollution Control Board, Delhi Pollution Control Committee, Irrigation and Water Resources departments of Haryana and Delhi.
- The study group has been asked to submit its report within a month.

### Ammonia

- It is one of several forms of nitrogen that exist in aquatic environments.
- Unlike other forms of nitrogen, which can cause nutrient over-enrichment of a water body at elevated concentrations and indirect effects on aquatic life, **ammonia causes direct toxic effects on aquatic life** according to the US Environment Protection Agency.
- Ammonia is mainly produced for commercial fertilizers and other industrial applications.

### Causes

- The possible reasons for high Ammoniacal Nitrogen could be discharge of untreated sewage from upstream towns in Haryana, discharge from industrial units, common effluent treatment plants (CETPs), sewage treatment plants (STPs), illegal discharge of sewage from unsewered colonies in outer Delhi through tankers, lean flow in the Yamuna and anaerobic decomposition of accumulated sludge on the riverbed.

4. c

- Tribals in Gujarat have been protesting against a notification of the Ministry of Environment, Forest and Climate Change.
- This notification had classified 121 villages around the Shoolpaneshwar Wildlife Sanctuary in Narmada district, Gujarat as eco-sensitive zones.

#### **Shoolpaneshwar Wild Life Sanctuary**

- It was created in 1982 as 'Dumkhal Sanctuary' - home for sloth bears.
- It is found at the congregation of Vindhyan-Satpura hill ranges.
- The sanctuary derives its name "Shoolpaneshwar" from a temple of Lord Shiva, which once existed in this region on the banks of river Narmada.
- The area is predominantly tribal with 'Vasavas' as the main tribe.

#### **Iran Nuclear Deal**

- The Iran nuclear deal, officially the Joint Comprehensive Plan of Action (JCPOA), was signed between **Iran and the P5 (the five permanent members of the UN Security Council)**—the US, UK, France, China and Russia) plus Germany and the European Union in Vienna in July 2015.
- It has also been referred as Vienna Accord, 2015.
- Under the agreement, which came into force in January 2016, Tehran agreed to limit its nuclear program in return for relief from crippling economic sanctions imposed by the UN, US and the EU.

#### **Lithium Metal**

- It is a soft, silvery-white alkali metal. Under standard conditions, it is the lightest metal and the lightest solid element.

- Lithium metal is isolated electrolytically from a mixture of lithium chloride and potassium chloride.
- Recently India has inked a pact with an Argentine firm to jointly prospect lithium in the South American country.
- Australia and Chile are world's leading lithium-producing country over the past decade.
- At the same time both the nations are top 2 countries that hold abundant lithium resources, where Chile has 55.5% of world's lithium reserves and Australia has 18.1%, where Argentina (11%) has 3rd largest reserves of the metal.

#### **Edible Mushroom**

- Union government has advised state governments to include mushrooms in the Integrated Child Development Services (ICDS) and Mid-Day Meals (MDM) schemes.
- These suggestions were on the inclusion of pre-primary classes in the MDM scheme and the provision of a simple and energetic breakfast under the scheme.
- Edible Mushroom contains mineral like potassium, copper, iron and phosphorus.
- It is rich in Vitamins B and they are exposed to sunlight, making them a natural source of D2.
- Choline in Mushroom helps in muscle movement, maintaining structure of cellular membranes and memory.
- The antioxidant compounds such as polyphenols, polysaccharides, ergothioneine, glutathione, and selenium are known to be behind the mushrooms' cancer-fighting ability.

#### **Grand Renaissance Dam**

- Its construction was initiated in 2011 on the Blue Nile tributary of the river that runs across one part of Ethiopia.
- The dam will full fill Ethiopia's goal to secure electricity for its population and to sustain and develop its growing manufacturing industry.

- The dam has created dispute among Ethiopia and Egypt, with Sudan having found itself dragged into the issue.

#### **Uranium Enrichment**

- It is a process that is necessary to create an effective nuclear fuel out of mined uranium by increasing the percentage of uranium-235 which undergoes fission with thermal neutrons.
- Nuclear fuel is mined from naturally occurring uranium ore deposits and then isolated through chemical reactions and separation processes.
- These chemical processes used to separate the uranium from the ore are not to be confused with the physical and chemical processes used to enrich the uranium.
- The enrichment process requires the uranium to be in a gaseous form.
- This is achieved through a process called conversion, where uranium oxide is converted to a different compound (uranium hexafluoride) which is a gas at relatively low temperatures.

- Dr. Harsh Vardhan, Union Minister for Health & Family Welfare has released the India Report on Longitudinal Ageing Study of India (LASI) Wave-1 recently.

### Longitudinal Ageing Study of India (LASI)

- It is a full-scale national survey of scientific investigation of the health, economic, and social determinants and consequences of population ageing in India.
- The **National Programme for Health Care of Elderly**, Ministry of Health & Family Welfare has undertaken the Longitudinal Ageing Study of India, through International Institute for Population Sciences, (IIPS), Mumbai.
- The study was conducted in collaboration with Harvard School of Public Health, University of Southern California, USA, Dte.GHS, United

Nations Population Fund (UNFPA) and National Institute on Ageing.

- The LASI, Wave 1 covered a baseline sample of individuals aged 45 and above and their spouses including elderly persons aged 60 and above and oldest-old persons aged 75 and above from all States and Union Territories (UTs) of India (excluding Sikkim).
- It is India's first and the world's largest ever survey that provides a longitudinal database for designing policies and programmes for the older population in the broad domains of social, health, and economic well-being.
- The evidence from LASI will be used to further strengthen and broaden the scope of National Programme for Health Care of the Elderly and also help in establishing a range of preventive and health care programmes for older population and most vulnerable among them.

- In 2011 census, the 60+ population accounted for 8.6% of India's population, accounting for 103 million elderly people.
- Growing at around 3% annually, the number of elderly age population will rise to 319 million in 2050.
- 75% of the elderly people suffer from one or the other chronic disease.

- If Earth were where the dwarf planet Pluto is, all its water would freeze; on the other hand, if Earth were where Mercury is, all its water would boil off.

- *Telangana has become the 3rd State in the country to successfully undertake "Urban Local Bodies (ULB)" reform stipulated by the Department of Expenditure, Ministry of Finance.*
- Thus, the State has become eligible to mobilise additional financial resources of Rs.2,508 crore through Open Market Borrowings.
- Telangana has now joined the two other States namely, Andhra Pradesh and Madhya Pradesh, who have completed this reform.
- On completion of urban local bodies reform, these three States have been granted additional borrowing permission of Rs.7,406 crore.

### **Scheme for Special Assistance to States for Capital Expenditure**

- The scheme was announced by the Finance Minister on 12th October, 2020 as a part of the AatmaNirbhar Bharat package.
- The Scheme is aimed at boosting capital expenditure of the State Governments who are facing difficult financial environment this year due to the shortfall in tax revenue arising from the COVID 19 pandemic.

- The Scheme has three parts.

#### **Part –I**

- It covers the north-eastern region.
- Under this part, Rs.200 crores is allocated to 7 north-eastern States (Arunachal Pradesh, Meghalaya, Manipur, Mizoram, Nagaland, Sikkim and Tripura).
- In view of higher population and geographical area, Assam has been allocated Rs.450 crores under the scheme.

#### **Part-II**

- It is for all other States not included in Part-I.
- An amount of Rs.7,500 crores is earmarked for this part.
- This amount has been allocated amongst these States in proportion to their share of central tax as per the interim award of the 15th Finance Commission for the year 2020-21.

#### **Part-III**

- It is aimed at pushing various citizen-centric reforms in the States.
- Under this Part, an amount of Rs.2000 crores is earmarked.
- This amount will be **available only to those States who carry out at least 3 out of the 4 reforms specified by the Ministry of Finance.**
- The 4 reforms are:
  1. Power Sector Reform
  2. One Nation One Ration Card
  3. Ease of doing Business Reform
  4. Urban Local Body/ Utility Reform

- An added advantage for Tier 2 AEOs is that their exports to certain countries are accorded facilitation by the foreign Customs administration with whom India enters into a Mutual Recognition Agreement/Arrangement.

- The SEEA provides frameworks for producing accounts in several thematic areas, including:
  1. Land Accounts
  2. Water Accounts
  3. Ecosystems Accounts
  4. Material Flow Accounts
  5. Air Emissions Accounts
  6. Energy Environmental Activity Accounts
  7. Agriculture, Forests, and Fisheries Accounts

- *The second and final Session of India's seventh Trade Policy Review (TPR) concluded recently at the World Trade Organization in Geneva.*

#### **Trade Policy Review (TPR)**

- It is an important mechanism under the WTO's monitoring function.
- It was an early result of the **Uruguay Round**.

#### **National Internet Exchange of India (NIXI)**

- It is a **not for profit Organization** under section 8 of the Companies Act 2013, and was registered on 19th June, 2003.
- NIXI was set up for peering of ISPs among themselves for the purpose of routing the domestic traffic within the country, instead of taking it all the way to US/Abroad, thereby resulting in better quality of service (reduced latency) and reduced bandwidth charges for ISPs by saving on International Bandwidth.
- NIXI is managed and operated on a Neutral basis, in line with the best practices for such initiatives globally.
- Any ISP can join NIXI.
- **NIXI is not an ISP** and will not provide Internet connections or Transit services.

#### **Functions**

- It is working since 2003 for spreading the internet technology to the citizens of India through the following activities: -
  1. Internet Exchanges through which the internet data is exchanged amongst ISPs and between ISPs and CDNs.
  2. IN Registry, managing and operation of IN country code domain and IDN domain for India.
  3. IRINN, managing and operating Internet protocol (IPv4/IPv6).

#### **Ozone Depleting Substances (OSD)**

- ODS compound contributes to stratospheric ozone depletion, they include

- The Equalization Levy was introduced for the first time in 2016 as 6% tax on revenues earned by non-residents from online advertising and related services.

### **Gross Domestic Product Estimates**

- Gross domestic product (GDP) is the monetary value of all finished goods and services made within a country during a specific period.
- India has registered an average annual GDP growth rate of 6.8 per cent since the start of economic liberalisation in 1992-93.
- According to recent estimates real GDP will fall by 7.7 per cent.
- A big reason for the contraction this year has been the disruption caused by Covid-induced lockdowns, as a result, the domestic economy had entered a technical recession.
- India's real GDP that is, GDP without the influence of inflation in 2020-21 will be lower than the 2018-19 level.

- In other words, from the start of the next financial year, India would first have to raise its GDP back to the level it was at in 2019-20.

### ***Culling of Infected Birds***

- During culling operations, all domestic birds in an infected area, i.e., an area in which a case of bird flu has been detected, are slaughtered and their remains buried.
- In India, culling is done in a radius of one kilometre from the site of infection, which is called the 'infected zone'.
- This means all domestic birds present in commercial farms, backyard farms or live bird markets in the infected zone are culled.
- Normally, the World Organization for Animal Health OIE says, the cervical dislocation or neck-wrangling method may be used by first making the poultry unconscious.
- The OIE manual says cervical dislocation is non-invasive killing method and can be performed manually on small birds, but it is difficult in larger birds and results in operator fatigue.

### ***K-Shape Curve in Economy***

- A K-shaped recovery occurs when, following a recession, different parts of the economy recover at different rates, times, or magnitudes.
- It describes the path of different disaggregated economic variables, such as income across different segments of society or employment in different industries, relative to one another.
- In India, households at the top of the pyramid are likely to have seen their incomes largely protected, and savings rates forced up during the lockdown.
- Meanwhile, households at the bottom are likely to have witnessed permanent hits to jobs and incomes.
- COVID has triggered an effective income transfer from the poor to the rich, this will be demand-impeding because the poor have a higher marginal propensity to consume (i.e) they tend to spend (instead of saving) a much higher proportion of their income.

- There are five major types of silk of commercial importance, obtained from different species of silkworms.
- These are Mulberry, Oak Tasar & Tropical Tasar, Muga and Eri.
- India has the unique distinction of producing all these commercial varieties of silk.

- *The Antarctic ozone hole — one of the deepest, largest gap in the ozone layer in the last 40 years — has closed, according to World Meteorological Organization (WMO).*



### Ozone Hole

- An ozone hole is the thinning of the ozone layer boosted in size by colder temperatures.
- The Antarctic ozone hole is a naturally occurring phenomenon, first discovered in 1985, that typically **opens up each year from August to December**.
- By the end of December, ozone levels return to normal.

### Causes

- The formation of ozone hole in the Antarctic has been an annual occurrence and has been recorded for the last 40 years.
- The expansion of the hole was driven by a strong, stable and cold polar vortex and very cold temperatures in the stratosphere.
- Human-made chemicals migrate into the stratosphere and accumulate inside the polar vortex.

### Polar Vortex

- It is a large area of low pressure and cold air surrounding the Earth's North and South poles.
- The term vortex refers to the counter-clockwise flow of air that helps keep the colder air close to the poles.
- It weakens in summer and strengthens in winter.
- Often during winter in the Northern Hemisphere, the polar vortex will become less stable and expand, sending cold Arctic air southward over the United States with the jet stream.

### Weakening of Polar Vortex

- As the temperatures high up in the stratosphere starts to rise, ozone depletion slows, the polar vortex weakens and breaks down.
- By the end of December, ozone levels return to normal.

### Montreal Protocol

- The Montreal Protocol on Substances that Deplete the Ozone Layer regulates production and consumption of nearly 100 chemicals

referred as Ozone Depleting Substances (OSD).

- Since the ban on halocarbons, the ozone layer has slowly been recovering, according to WMO.

- The river is very much aggrading in nature. This is why the river has a tendency to shift its course towards the left bank.

#### **Lithium Extraction**

- Under standard conditions, Lithium is the lightest metal and the lightest solid element.
  - It is an alkali metal and a rare metal.
  - Recently a survey found presence of 1,600 tonnes of lithium resources in the igneous rocks of the Marlagalla-Allapatna region of Karnataka's Mandya district.
  - Lithium can be extracted in different ways, depending on the type of the deposit, few examples are
1. **Solar evaporation of large brine pools** - A brine pool is a volume of brine collected in a seafloor depression.
  2. **Hard-rock extraction of the ore** (a metal-bearing mineral) - Lithium is extracted through rock mining at Mandya, Karnataka.

#### **Virunga National Park**

- The government has nominated 28 non-official members for the National Startup Advisory Council recently.

#### National Startup Advisory Council

- The Department for Promotion of Industry and Internal Trade (DPIIT) had set up the National Startup Advisory Council last year.
- It seeks to advise the government on measures needed to build an ecosystem for nurturing innovation and startups in the country.
- The term of the Non-official members of the Startup Advisory Council shall be for a period of two years.
- The council is chaired by the Union Minister for Commerce and Industry.

- Drone is a layman terminology for Unmanned Aircraft (UA).
- There are three subsets of Unmanned Aircraft,
  1. Remotely Piloted Aircraft
  2. Autonomous Aircraft
  3. Model Aircraft
- An aircraft and its associated elements, which are operated with no pilot on board is called as Unmanned Aircraft System (UAS).

- Remotely Piloted Aircraft System (RPAS) is one subset of UAS.
- Civil Remotely Piloted Aircraft (RPA) is categorized as follows:

  2. Micro : Greater than 250 grams and less than or equal to 2 kg.
  3. Small : Greater than 2 kg and less than or equal to 25 kg.

- UIN is unique identification number issued by DGCA for a particular RPA.
- Nano RPA (less than 250 gm) is exempted from obtaining UIN and UAOP.
- Foreigners are currently not allowed to fly drones in India. For commercial purpose, they need to lease RPAS to an Indian entity who in turn will obtain Unique Identification Number (UIN) and UAOP from DGCA.

- The Question Hour, which had been suspended by the government during the monsoon session, will resume when Parliament meets for the Budget session.

#### Question Hour

- During this time, the members ask questions and the ministers usually give answers.
- The questions are of three kinds, namely, starred, unstarred and short notice.
  1. A starred question (distinguished by an asterisk) requires an oral answer and hence supplementary questions can follow.
  2. An unstarred question, on the other hand, requires a written answer and hence, supplementary questions cannot follow.
  3. A short notice question is one that is asked by giving a notice of less than ten days. It is answered orally.
- Parliament has comprehensive rules for dealing with every aspect of Question Hour and the presiding officers of the two houses are

the final authority with respect to the conduct of Question Hour.

- Usually Question Hour is the first hour of a parliamentary sitting.
- In 2014, Rajya Sabha Chairman Hamid Ansari shifted Question Hour in the House from 11 am to 12 noon.
- The move was to prevent the disruption of Question Hour.

- In December 2020, NITI Aayog released the first-of-its-kind draft guidelines, titled 'Guiding Principles for the Uniform National-Level Regulation of Online Fantasy Sports Platforms in India'.
- These guidelines emphasise the need to differentiate between fantasy sports and online gaming, create an independent identity of the fantasy sports industry, and appoint a single-purpose self-regulatory industry body for governance.

- It is a large terrestrial bird found in parts of Asia, the Middle East and Africa.
- The North African houbara (*Chlamydotis undulata*) and the Asian houbara (*Chlamydotis macqueenii*) are separate species.
- The Asian houbara is related to the critically endangered great Indian bustard native to India.
- The IUCN lists the birds as vulnerable, and the CITES has placed them on the most sensitive listing i.e. Appendix I which prohibits any commercial trade of these birds.

- Recently, the Ministry of Earth Sciences has commissioned two of the ten indigenously built Doppler weather radars.
- The DWR provides detailed information on storm's internal wind flow and structure.
- Modern weather radars are mostly pulse-Doppler radars, capable of detecting the motion of rain droplets in addition to the intensity of the precipitation.
- Both types of data can be analysed to determine the structure of storms and their potential to cause severe weather.
- The DWR, can detect Weather phenomenon up to 500 km.
- The system installed at a place that receives the highest rainfall in Planet Earth, shall open up tremendous research opportunities in the areas of monsoon dynamics, precipitation characterisation, thunderstorm and hailstorm genesis and evolution, etc.

- The Doppler weather radars will closely monitor the weather changes over the Himalayas.

#### **Lumpy Skin Disease**

- It is primarily spread between animals by biting insects (vector), such as mosquitoes and biting flies.
- The virus, which is closely related to the pox viruses of sheep and goats, and causes nodular skin lesions on the animal's body.
- It has remained confined to Africa, where it was first discovered in 1929, and parts of West Asia, so far the disease has not occurred in North America.
- The most apparent sign of the disease will be multiple nodules on the body, including the muzzle, nostrils, head, neck, back, legs, scrotum, perineum, udder, eyelids, nasal and oral mucosa, and tail.
- The humans are not at risk of developing lumpy skin disease.

#### **Open Skies Treaty (OST)**

- It is an accord between over 30 countries that allows participants to fly unarmed reconnaissance flights over any part of their fellow member states.
- It went into effect in 2002 and had 35 signatories, including key players US and Russia, along with one non-ratifying member (Kyrgyzstan), recently both Russia and USA as opted out of the treaty.
- The OST aims at building confidence among members through mutual openness and thus reducing the chances of accidental war.
- The information gathered, such as on troop movements, military exercises and missile deployments, has to be shared with all member states.
- Under the treaty, only approved imaging equipment is permitted on the surveillance flights, and officials from the host state can also stay on board throughout the planned journey.

#### **Open Sky Agreements**

- These are bilateral agreements that the two countries negotiate to provide rights for airlines to offer international passenger and cargo services.
- It expands international passenger and cargo flights.
- UAE has expressed interest to have an Open Sky Agreement with India, it will allow unlimited number of flights to the selected cities of each other's countries.

### Smart Anti-Airfield Weapon (SAAW)

- It is indigenously designed and developed by DRDO's Research Centre Imarat (RCI) Hyderabad.
- This is 125 Kg class smart weapon, capable of engaging ground enemy airfield assets such as radars, bunkers, taxi tracks, and runways etc. up to a range of 100 kms.
- The high precision guided bomb is light weight as compared to weapon system of the same class.
- The weapon was earlier successfully test fired from Jaguar aircraft.
- The smart weapon was now successfully test fired from Indian Hawk-Mk132 of HAL.
- This was the 9th successful mission of SAAW conducted by DRDO till now.
- It was a text book launch, which met all mission objectives.

- Anukampa Dashakam (Ten verses on Compassion) is a poem written by Sree Narayana Guru in Malayalam language.

- The Indian station **Himadri** was inaugurated in 2008.
- **National Centre for Polar and Ocean Research (NCPOR)** (erstwhile **NCAOR**) is India's premier R&D institution responsible for the country's research activities in the Polar and Southern Ocean realms.

#### **Wild life Protection Act, 1972**

- This Act provides for the protection of a listed species of animals, birds, and plants, and also for the establishment of a network of ecologically-important protected areas in the country.
- Under the act, Schedule V contains animals that can be hunted and Schedule VI contains plants that are forbidden from cultivation.

#### **Confusion over Scientific Names**

##### **Background**

- In recent times, confusion over names of species listed in the schedules of WLPA hinders fight against wildlife crime in India.
- For example, in 2016, forest department of Kerala's Pathanamthitta district seized a turtle from George Kurian.
- Investigations identified the species as the Indian Flapshell, whose scientific name is *Lissemys punctata*.
- The district court ordered that the turtle be freed the next day and Kurian was charged under the Wild Life (Protection) Act, 1972, (WLPA).
- But the law incorrectly lists *Lissemys punctata*'s common name as the Indian Softshell turtle.

- Kurian challenged the charges in the Kerala High Court on the grounds that since the Indian Flapshell turtle does not find a mention in the schedules of WLPA and the court quashed the charges against Kurian.

#### **Issues**

- Confusion over names of species listed in the schedules of WLPA occurs because scientific and common names have never been updated in the Act.
- Scientific names are revised whenever a new understanding of the species emerges.
- However, there has been **no revision in names under WLPA since it came into force in 1972**.
- In fact, **progress made by science in terms of both naming a species as well as identifying new species within a genus is not reflected in WLPA**.

#### **Radio Access Network (RAN)**

- A RAN resides between user equipment, such as a mobile phone, a computer or any remotely controlled machine, and provides the connection with its core network.
- Open-RAN is not a technology, but rather an ongoing shift in mobile network architecture that allows networks to be built using subcomponents from a variety of vendors.
- O-RAN has an open, multi-vendor architecture for deploying mobile networks, as opposed to the single-vendor proprietary architecture.
- O-RAN uses software to make hardware manufactured by different companies work together.
- The key concept of Open RAN is "opening" the protocols and interfaces between the various subcomponents (radios, hardware and software) in the RAN.

- Risa is primarily used as a breast cloth and is woven in different colourful designs.

### **Section 32 of Insolvency and Bankruptcy Code**

- Recently, the Supreme Court upheld the validity of Insolvency and Bankruptcy Code (IBC) Amendment Act 2020.
- The Supreme Court held that the successful bidders for a corporate debtor under the Insolvency and Bankruptcy Code (IBC) would be immune from any investigations being conducted either by any investigating agencies.
- The court said that it was important for the IBC to attract bidders who would offer reasonable and fair value for the corporate debtor to ensure the timely completion of corporate insolvency resolution process (CIRP).
- The court said that the protection must also extend to the assets of a corporate debtor, which form a crucial attraction for potential bidders and helps them in assessing and placing a fair bid for the company.
- The apex court has said that such immunity would be applicable only if there is an approved resolution plan, and a change in the management control of the corporate debtor.

### **Nitrogen-Use Efficiency**

- NUE is calculated as a ratio between nitrogen used and harvest, a higher number denotes low wastage.

- With the efficiency on the decline, farmers use more fertiliser in the hope of raising yield, this in turn worsens NUE.
- Crops generally use up 30% of nitrogen fertilizer applied, the rest seeps into the environment, harming health and adding to climate change.
- Researchers were able to identify phenotypes or visibly identifiable features that determine the efficiency with which cultivated rice varieties use nitrogen.
- This efficiency is known as nitrogen-use efficiency (NUE).
- Cereals consume over 69% of nitrogen fertilizers. Rice consumes 37%, followed by wheat (24%).

- Recently, the Telecom Regulatory Authority of India (TRAI) has released the "Indian Telecom Services Performance Indicator Report".
- Parameters used for calculating the index are as follows

- Key Findings of the report are as follows
  1. The overall Tele-density in India also increased from 85.85% as in QE Jun-20 to 86.22% as in QE Sep-20.
  2. The Urban Tele density also increased from 137.35% to 138.25% during the same period.

### *Carbon sequestration*

- Carbon sequestration is the long-term storage of carbon in plants, soils, geologic formations, and the ocean.
- Carbon sequestration types are as follows

1. **Terrestrial Carbon Sequestration** - It is the process through which CO<sub>2</sub> from the atmosphere is absorbed by trees and plants through photosynthesis and stored as carbon in soils and biomass (tree trunks, branches, foliage, and roots)
2. **Geologic Carbon Sequestration** - CO<sub>2</sub> can be stored, including oil reservoirs, gas reservoirs, unmineable coal seams, saline formations and shale formations with high organic content.
3. **Ocean Carbon Sequestration** - Oceans absorb, release and store large amounts of CO<sub>2</sub> from the atmosphere.
  - This can be done in two ways enhancing productivity of ocean biological systems through Iron fertilization, and injecting CO<sub>2</sub> into the deep ocean.
  - The dumping of iron stimulates phytoplankton production, which in turn leads to enhanced photosynthesis from these microorganisms, helping in CO<sub>2</sub> absorption.

#### **Guru Gobind Singh**

- He is tenth Sikh Gurus, his birth anniversary is commemorated based on the Nanakshahi calendar.

#### **Nanobodies**

- Conventional antibodies have two variable domains, called VH and VL, which offer each other stability and binding specificity.
- Nanobodies have VHH domains and lack VL domains, but are still highly stable.
- Thus these are antibodies with a single variable domain located on a heavy chain, also known as VHH antibodies
- Lacking the VL domain also means nanobodies have a hydrophilic (they do not have issues with solubility) side.
- Nanobody production has distinct advantages not available with traditional antibodies, such as improved screening, improved isolation techniques, and no animal sacrifice.



- They are also used as immunoreagent for the analysis of small molecular weight environmental chemicals.
- Recently researchers has developed novel antibody fragments (nanobodies) against SARS-CoV-2.

### **Grid-connected Rooftop Solar Scheme**

- It aims to promote the grid-connected Solar Photovoltaic (SPV) rooftop and small SPV power generating plants among the residential, community, institutional, industrial and commercial establishments.
- In a grid-connected rooftop or small Solar Photovoltaic (SPV) system wherein the DC power generated from the SPV panel is converted to AC power using the power conditioning unit and is fed to the grid.
- This scheme is being implemented in the state by distribution companies (DISCOMs) and no other agency is authorised by the Ministry to implement the scheme.
- Under this scheme the Ministry is providing a 40% subsidy for the first 3 kW and 20% subsidy beyond 3 kW and up to 10 kW of solar panel capacity.
- The residential consumer has to pay the cost of rooftop solar plant by reducing the subsidy amount given by the Ministry as per the prescribed rate to the vendor.

- Union Home Minister has recently participated in an event commemorating one year of the signing of the Boda Accord, 2020.

### Bodo Accord

- It is the third peace deal with Bodo rebel groups that was signed in New Delhi on January 2020 by the Centre.
- It was signed with all four factions of National Democratic Front of Bodoland (NDFB), the All Bodo Students Union (ABSU) and United Bodo Peoples' Organisation (UBPO).
- The Bodoland Territorial Region (BTR) Accord has triggered the process of ending insurgency in the North-East and was able to bring peace to the troubled region in Assam.

### Bodoland Territorial Council (BTC)

- It is an autonomous body under the Sixth Schedule of the Constitution.
- There have been two Bodo Accords earlier, and the second one led to the formation of BTC.
- The area under the jurisdiction of BTC, formed under the 2003 Accord, was called the Bodo Territorial Autonomous District (BTAD).
- Later, BTAD was renamed as Bodoland Territorial Region (BTR).

- BTAD comprises Kokrajhar, Chirang, Baksa and Udalguri districts, accounting for 11% of Assam's area and 10% of its population.

### Bodo Tribes

- They are the single largest community among the notified Scheduled Tribes in Assam.
- Part of the larger umbrella of Bodo-Kachari, the Bodos constitute about 5-6% of Assam's population.

- The first-ever treaty to ban nuclear weapons has recently entered into force.
- It is an historic step marred by the lack of signatures from the world's major nuclear powers.

### Treaty on the Prohibition of Nuclear Weapons (TPNW)

- In July 2017, the UN negotiating conference had adopted the legally binding Treaty on the Prohibition of Nuclear Weapons (TPNW).
- As its name suggests, the treaty limits signatories to not "develop, test, produce, manufacture, otherwise acquire, possess or stockpile nuclear weapons or other nuclear explosive device".
- When the treaty was approved, more than 120 approved it. But none of the nine countries known or believed to possess nuclear weapons — the United States, Russia, the United Kingdom, China, France, India, Pakistan, North Korea and Israel — supported it, and neither did the 30-nation NATO alliance.
- Japan, the world's only country to suffer nuclear attacks, also does not support the treaty.
- Japan on its own renounces the use and possession of nuclear weapons, but the government has said pursuing a treaty ban is not realistic with nuclear and non-nuclear states so sharply divided over it.
- With the UN nuclear ban treaty entering into force, India also reiterated that ***it is neither party to nor bound by any obligations of the international pact.***

#### **National Company Law Appellate Tribunal (NCLAT)**

- It was constituted under Section 410 of the Companies Act, 2013 for hearing appeals against the orders of National Company Law Tribunal(s) (NCLT).
- NCLAT is also the Appellate Tribunal for hearing appeals against the orders passed by NCLT(s) under Section 61 of the Insolvency and Bankruptcy Code, 2016 (IBC).

- NCLAT is also the Appellate Tribunal for hearing appeals against the orders passed by Insolvency and Bankruptcy Board of India under Section 202 and Section 211 of IBC.
- NCLAT is also the Appellate Tribunal to hear and dispose of appeals against any direction issued or decision made or order passed by the Competition Commission of India (CCI).

- Minister for Environment, Forest and Climate Change, Shri Prakash Javadekar and Ms Barbara Pompili, the French Minister for Ecological Transition jointly launched the Indo-French Year of the Environment in New Delhi recently.

### Indo-French Year of the Environment

- 2021 was designated as the Indo-French Year of the Environment.
- The basic objective is to strengthen Indo-French cooperation in sustainable development, increase the effectiveness of actions in favor of global environment protection and give them greater visibility.
- The Indo-French Year of the Environment over the period 2021-2022 would be based on five main themes:
  - Environmental protection
  - Climate change
  - Biodiversity conservation
  - Sustainable urban development
  - Development of renewable energies and energy efficiency
- It is also a platform for engaging in discussions on critical areas of collaboration relating to environment and allied areas.

2. d

- Union Home Minister Amit Shah has recently launched the 'Ayushman CAPF' Scheme.

### Ayushman CAPF Scheme

- It extends the healthcare benefits of the Central health insurance scheme to the seven Central Armed Police Forces (CAPFs) and their dependents.
- It is a joint initiative by the Ministry of Home Affairs and the National Health Authority (NHA).
- The scheme would provide cashless healthcare services to the serving CAPF personnel and their family members.

- It would be implemented across the country in a phased manner.
- The convergence between Ayushman Bharat and CAPF is a first of its kind initiative leveraging strengths of the existing robust IT framework, access to the network of various private hospitals and portability of services across the country.

- The National Board for Wildlife (NBWL) has recently recommended the de-notification of Galathea Bay Sanctuary, after local authorities submitted a proposal for it to the Union environment ministry citing an international shipment project.
- It has suggested the implementation of a mitigation plan to facilitate nesting of turtles as well as connectivity between the Galathea river and the Bay of Bengal.
- Great Nicobar Island and Little Andaman Island host the largest nesting population of leatherback turtles in the central or northern Indian Ocean.

### Leatherback Turtles

- They are named for their shell, which is leather-like rather than hard, like other turtles.
- They are extremely vulnerable to temperature extremes.
- It is the **only species without scales** and a hard shell.
- They are the largest sea turtle species and also one of the most migratory, crossing both the Atlantic and Pacific Oceans.
- Some of the turtles can swim over 10,000 miles a year between nesting and foraging grounds.
- Pacific leatherbacks migrate from nesting beaches in the Coral Triangle all the way to the California coast to feed on the abundant jellyfish every summer and fall.
- Although their distribution is wide, numbers of leatherback turtles have seriously declined during the last century as a result of intense egg collection and fisheries bycatch.
- Globally, leatherback status according to IUCN is listed as **Vulnerable**, but many

subpopulations (such as in the Pacific and Southwest Atlantic) are Critically Endangered.

#### ***Galathea Bay Wildlife Sanctuary***

- It is an important nesting site of leatherback sea turtles in the Andaman and Nicobar Islands.
- The Galathea National Park is located on the island of Great Nicobar in the Nicobar Islands, which lie in the eastern Indian Ocean (Bay of Bengal).
- Galathea National Park is a part of the Great Nicobar Biosphere Reserve.
- Campbell Bay National Park is another park of the Biosphere Reserve.

- In India, the practice of the President addressing Parliament can be traced back to the Government of India Act of 1919.
- This law gave the Governor-General the right of addressing the Legislative Assembly and the Council of State.
- Article 87 of Indian Constitution provides for special address by the President at the commencement of the first session after each general election to the House of the People and at the commencement of the first session of each year the President shall address both Houses of Parliament assembled together and inform Parliament of the causes of its summons.

#### ***Climate Risk Index 2021***

- Recently, an NGO based in Germany 'Germanwatch' has released the Global Climate Risk Index (CRI) 2021.
- The CRI analyses quantified impacts of extreme weather events both in terms of the fatalities and economic losses.
- The index is based on data from Munich Re's NatCatSERVICE.
- India ranks seventh among countries most affected in 2019 by climate change.

- Eight out of the ten countries most affected by the quantified impacts of extreme weather events in 2019 belong to the low- to lower-middle income category.
- Storms and their direct implications such as precipitation, floods and landslides were one major cause of losses and damages in 2019.
- UNDRR Releases Country specific Disaster Risk Reduction Report Annually.

#### ***Sudden Stratospheric Warming***

- The stratosphere is the layer of the atmosphere from around 10 km to 50 km above the Earth's surface.
- It is a rapid warming (up to about 50 °C in just a couple of days), between 10 km and 50 km above the earth's surface.
- SSW is related to the behaviour of the stratospheric polar vortex, a fast-blowing band of winds that forms over the Arctic region during the winter due to reduced solar radiation.
- During SSW the winds in the stratosphere can reverse from westerly to easterly.
- Thus, SSW are a natural atmospheric fluctuation, not caused by climate change.
- The weather in the atmospheric layers above the stratosphere mesosphere and thermosphere also get affected by SSW.
- This is a cause of concern for satellite navigation and other space-based human endeavours.
- SSW doesn't happen every year, and it doesn't always affect weather when it does.

#### ***Introduction of Cheetah in the Wild***

- The translocation of African Cheetah is a part of Government of India to reintroduce the fastest land animal in India after extinction of the Asiatic cheetah in the 1950s.
- A Supreme Court-appointed committee has found following sites for translocation of cheetahs because of an appropriate geophysical feature of forests.



1. Kuno National Park, Nauradehi Wildlife Sanctuary and Gandhi Sagar-Chittorgarh in Madhya Pradesh
2. Bhainsrogarh Sanctuary in Rajasthan.
- The areas are well protected and have well-managed grassland.
- The cheetah will be introduced on an experimental basis in the best suitable habitat to see whether it can adapt to Indian conditions.

### Global Risks Report 2021

- According to the report Infectious diseases topped the global risks chart, displacing climate change.
- COVID-19 has been the worst-ever health crisis faced by the world, it held back the economic development in some of the poorest parts of the world.
- As a result, the existing economic gap between the rich and poor in the world has widened.
- At the same time, all the countries diverted their resources from other health challenges.
- For example, vaccination programmes across the world were disrupted and postponed.
- The WEF report arrived at these results on the basis of a Global Risks Perception Survey completed by over 650 members of the forum's diverse leadership communities.

### Weakly Interacting Massive Particle (WIMP)

- Dark matter is a form of matter thought to account for approximately 85% of the matter in the universe.
- Weakly Interacting Massive Particle (WIMP) is hypothesized to make up some 22 percent of the universe, and is a candidate for non-baryonic dark matter.
- These particles are thought to be heavy and slow moving because if the dark matter particles were light and fast moving, they would not have clumped together in the density fluctuations from which galaxies and clusters of galaxies formed.

- The absence of light from these particles also indicates that they are electromagnetically neutral.
- The precise nature of these particles is not currently known, and they are not predicted by the standard model of particle physics.

- Agreement for the financial support of the implementation of STARS project was signed between Department of Economic Affairs (DEA) and World Bank along with Ministry of Education.

### Strengthening Teaching-Learning and Results for States (STARS) project

- The project would be implemented as a new Centrally Sponsored Scheme under Department of School Education and Literacy (DoSEL), MOE.

- The project covers 6 States viz **Himachal Pradesh, Rajasthan, Maharashtra, Madhya Pradesh, Kerala and Odisha.**
- The identified States will be supported for various interventions for improving the quality of education.

### Funding

- The total project cost of STARS project is Rs. 5718 crore with the financial support of World Bank amounting to US \$ 500 million (approximately Rs. 3700 crore) and rest coming as State share from the participating States, over a period of 5 years.

### Implementing Agency

- STARS will draw on existing structure under Samagra Shiksha with the DoSEL, MoE as the main implementing agency at the national level.
- At the State level, the project will be implemented through the integrated State Implementation Society (SIS) for Samagra Shiksha.

### National Educational Policy 2020

- STARS project will be instrumental in the implementation of various recommendations of National Education Policy 2020 like:
  1. Strengthening Early Childhood Education and Foundational Learning
  2. Improving Learning Assessment System
  3. ICT-enabled approaches in education
  4. Teachers Development and Vocational education etc.

2. c

- India is the **world's largest exporter of chili and turmeric**, the exports of which have recorded a steady progress, over the years.
- During 2019-20, India exported 4,84,000 tonnes of chili and chili products valued at Rs.6211.70 crores which contributed to more than 40 per cent in volume and 29 per cent in value of India's total spice exports.
- Turmeric held a share of 11 per cent in volume and 6 per cent in value of the export basket,



with an export of 1,36,000 tonnes valued at Rs.1216.40 crores.

### **Spices Board India**

- It is the flagship organization for the development and worldwide promotion of Indian spices.
- It is one of the five Commodity Boards functioning under the Ministry of Commerce & Industry.
- It is an autonomous body responsible for the export promotion of the 52 scheduled spices and development of Cardamom (Small & Large).
- The Board is an international link between the Indian exporters and the importers abroad.

- *Prime Minister Shri Narendra Modi will address the 125th anniversary celebrations of Prabuddha Bharata.*
- The event is being organized by Advaita Ashrama, Mayavati.

### **Prabuddha Bharata**

- It is a monthly journal of the Ramakrishna Order, started by Swami Vivekananda in 1896.
- It has been an important medium for spreading the message of India's ancient spiritual wisdom.
- Its publication was started from Chennai (erstwhile Madras), where it continued to be published for two years, after which it was published from Almora.
- Later, in April 1899, the place of publication of the Journal was shifted to Advaita Ashrama and it has been continuously published from there since then.
- Luminaries like Netaji Subhas Chandra Bose, Bal Gangadhar Tilak, Sister Nivedita, Sri Aurobindo, Former President Sarvepalli Radhakrishnan, among others, have contributed to the Journal over the years.

- *Power Finance Corporation, one of India's leading NBFC in power sector and a PSU under Ministry of Power, organized a technical workshop on Kanthasth*

*(Translation software based on memory) and Hindi e-tools recently at Urjanidhi, headquarters of PFC.*

- The workshop was organised in association with **Department of Official Language, Ministry of Home Affairs**, Government of India.

### **Kanthasth**

- It is basically a name given to this Machine Translation (MT) system.
- This MT system is based on Translation Memory (TM) approach.

### **Translation memory**

- It is a feature of computer-aided translation system which helps in the translation process.
- A translation memory is basically a database which stores the translated data in the form of aligned source-language and target-language segments.
- The main characteristic of the Translation memory system is that it allows a translator to re-use the already translated segments while translating a new file, either through complete match or partial match in TM.

### **Department of Official Language**

- It was set up in June 1975 as an independent Department of the Ministry of Home Affairs.
- It was created with a view to ensuring compliance of the constitutional and legal provisions regarding official language and to promote the use of Hindi for the official purposes of the Union.

### **Patharughat Uprising**

- In January 28, 1894 in Patharughat, a small village in Assam's Darrang district many local peasants gathered in a protest.
- The unarmed peasants were protesting against the increase in land revenue levied by the colonial administration, when the military opened fire.
- As a result, a rebellion brewed in the hearts of the peasants against the British.

- After much discussion amongst themselves, it was decided that no taxes would be paid to the British, until a proper solution was found to the problem.
- They were even willing to revolt against the British for the cause.
- While the protest meeting was going on, on the orders of Deputy Commissioner of Darrang district, Barrington, police opened fire on the gathering present there.
- Hundreds of people were injured and around 140 of them were killed on spot.

### **Neglected Tropical Diseases (NTD)**

- Neglected tropical diseases (NTDs) are a diverse group of tropical infections which are common in low-income populations in developing regions of Africa, Asia, and the Americas.
- Dengue, Rabies, Leprosy (Hansen disease), Blinding trachoma, Buruli ulcer, Endemic treponematoses (yaws) are few examples of NTD.
- These diseases are contrasted with the big three infectious diseases (HIV/AIDS, tuberculosis, and malaria), which generally receive greater treatment and research funding.
- 1 in 5 people around the world are affected by NTDs.
- India is home to the world's largest absolute burden of at least 11 of major neglected tropical diseases.

### **World Economic Situation & Prospects 2021**

- According to the report the world economy was hit by a once-in-a-century crisis i.e. a Great Disruption unleashed by the COVID-19 pandemic in 2020.
- The global economy shrank by 4.3 per cent last year, over two-and-a-half times more than during the global financial crisis of 2009.
- The report said economic growth in South Asia in 2021 will be insufficient, at 6.9 per cent.

- The report highlighted Indian economy, which grew at 4.7 per cent in 2019, will contract by 9.6 per cent in calendar year 2020.

### **EDISON Alliance**

- The World Economic Forum (WEF) has announced the launch of an Essential Digital Infrastructure and Services Network (EDISON) Alliance.
- It is as an international organisation for public-private partnership, WEP will serve as the secretariat and platform for the EDISON Alliance.
- Its prime goal is to ensure an unprecedented level of cross-sectoral collaboration between the technology industry and other critical sectors of the economy, according to the WEF.

### **Corruption Perception Index (CPI)**

- Transparency International releases the Corruption Perception Index (CPI).
- The CPI scores 180 countries and territories only based on their perceived levels of public sector corruption, according to experts and businesspeople.
- It uses a scale of 0 to 100, where 0 is highly corrupt and 100 is very clean.
- Each data source used to construct the CPI must fulfil the following criteria to qualify as a valid source:
  1. Quantifies risks or perceptions of corruption in the public sector
  2. Is based on a reliable and valid methodology
  3. Comes from a reputable Organisation
  4. Allows for sufficient variation of scores to distinguish between countries
  5. Ranks a substantial number of countries
  6. Considers only the assessments of country experts or businesspeople
  7. Is regularly updated
- For a country or territory to be included in the CPI, a minimum of three sources must assess that country.

- India's rank has slipped to 86th in CPI 2020 as compared to 80th position out of 180 countries in 2019.
